We unite communities of all races, genders, ages and classes to fight for civil and human rights locally and globally. We engage the community through Listening Sessions, Cafe con El Centro, Comadres Women's Support Group, cultural events (including Cinco de Mayo and Dia de los Muertos), social media and e-newsletters. Volunteerism is the lifeblood of the organization, and our Volunteer Program recruits more than 1,200 volunteers a year to ensure that our program participants achieve their outcomes.
