### MISSION STATEMENT:

As an organization grounded in the Latino community of Washington State, it is the mission of El Centro de la Raza (The Center for People of All Races) build the Beloved Community\* through unifying all racial and economic sectors; to organize, empower, and defend the basic human rights of our most vulnerable and marginalized populations; and to bring critical consciousness, justice, dignity, and equity to all the peoples of the world.

### JOB SUMMARY:

*Temporary Summer Position, Employment from June 24- August 20, 2024*

The ‘Echale Ganas Summer Institute’ brings together 35 rising Latina/o middle school youth to build community, establish summer friendships, and enter the next school year at or above grade level. Our program is designed to foster an atmosphere of collective learning, celebration and fun! Scholars in our program receive academic support in Language Arts, Math/Science and Ethnic Studies. Youth also venture on weekly field trips focus on exploring their Pacific Northwest backyard.

As the STEM Instructor, you will teach 2 cohorts of middle school students as they improve their knowledge of math and science concepts. The STEM Instructor will design a curriculum following a student center model integrating opportunity for scholars to practice math skills and explore hands on concepts related to science. As the instructor, you will be trusted to design daily lessons that allow for exploration of both subjects each day. We seek an individual passionate about youth development and who can align to the mission of El Centro De La Raza. Spend your summer supporting the next generation of scholars to establish their ‘amor’ for STEM!

### ESSENTIAL QUALIFICATIONS:

- B.A. degree in Math, Sciences, Education or related field.
- 2+ years of teaching or other relevant experience working with BIPOC Youth
- Ability to build rapport and authentic relationships with youth identifying as Latino, Immigrant or Non-English Speakers.
- Bilingual Spanish/English both written and oral fluency preferred.
- Familiarity with Latino community, immigrant communities and/or diverse communities.
- Curriculum Development Experience. Understanding of project based curriculum development.

**ESSENTIAL FUNCTIONS:**

- Design a 6-week Math/Science curriculum for middle school aged youth to be facilitated Monday-Thursday for 60 minutes.
- Teach two cohorts of middle school students; each cohort will have 15 students enrolled comprised of 6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup> grade.
- Provide project-based learning experiences that present scholars with an opportunity to improve their math skills and understanding of science concepts.
- Incorporate connection of math and science concepts to Latina/o culture.
- Design hands on activities, that build scholar soft skills such as public speaking, group work and collaboration.
- Support the development of community commodities among participants. Participate in spirit days alongside scholars.
- Understanding of a strengths-based approach. Commitment to disrupting the school to prison pipeline.
